Family Stability Grant	St. Vincent de Paul Georgia's (SVdP's) Family Stability Grant offers a 50% match up of conference direct aid to homeless families including shelter, housing and wrap-around support. Georgia Rehousing Initiative	The Georgia Rehousing Initiative (GRI) is a \$150,000 set-aside for conferences to support rapid rehousing for homeless families. Financial assistance supports move-in costs, deposit and/or a portion of the first month's rent.	<ul style="list-style-type: none"> – Household includes at least one child under age 18. – Rent is 40% or less of total income – Family must have an approved housing application with a welcome letter from the landlord 	Statewide
MARI – Metro Atlanta Rehousing Initiative 	MARI is a rapid rehousing program limited to Metro Atlanta. Financial assistance supports move-in costs, deposit, and/or a portion of the first month's rent.	<ul style="list-style-type: none"> – Income from employment, retirement, SSI or SSDI – Accepted for housing, with a welcome letter from the landlord – Rent is less than 40% of current income 	Butts, Cherokee, Coweta, Cobb, Clayton, Dekalb, Douglas, Fayette, Fulton, Gwinnett, Henry, Paulding, and Rockdale counties

<p>House of Dreams</p> 	<p>3-bedroom apartment homes sponsored by St. Thomas the Apostle Catholic Church. Program includes mandatory life- and work-skill classes to help residents obtain and maintain employment, and save. Includes volunteer case management support.</p>	<ul style="list-style-type: none"> – Women, age 25+ – No dependents – No criminal, alcohol, or drug history – No medical issue that prohibits employment – Employed within the last 3-6 mos. or currently working – US citizen (or legal resident) with valid SSN 	<p>Smyrna, GA Cobb County</p>
<p>Marillac Moms</p> 	<p>Private, 12-15 month apartment lease for a homeless, single pregnant mother with children currently in her care. Includes life- and work-skills, job assistance, and maternity-leave respite and mentoring with a goal of building self-sufficiency and a stable home environment</p>	<ul style="list-style-type: none"> – Confirmation of pregnancy; first or second trimester – Children currently in her care – Homeless --Agreement to comply with home and program rules and program stipend 	<p>Statewide (current homes in Cobb, Gwinnett and Fulton counties)</p>

<p>St. Michael's House</p> 	<p>Group home at St. Michael the Archangel Catholic Church for single mothers. Includes life- and work-skills (such as finance and budget training, nutrition and cooking, goal setting and decision making, child rearing and nurturing), other skills and spiritual direction</p>	<ul style="list-style-type: none"> – Women with children – Maintain employment throughout her stay – Willingness to: <ul style="list-style-type: none"> • Set and achieve short-term and long-term goals • Demonstrate progress towards financial stability • Nurture and participate in her children's growth. • Live peacefully with other women in the program. • Observe precepts from SVdP. 	<p style="text-align: center;">Woodstock, GA Cherokee County</p>
<p>Motel 2 Home</p> 	<p>Provides move-in deposits, up to \$2000, once housing has been found.
